WCTO "CODY JOHNSON WEEK" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WCTO/WWYY ("Station"), 2158 Avenue C, Suite 100, Bethlehem, PA 18017, during available business hours Monday through Friday, Station website <u>www.catcountry</u>96.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **Cat Country 96 & 107.1** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.  - (i) <u>Text</u>: Listen for the keyword to be announced on-air each day during the regular contest period. Each day, Monday through Sunday the keyword will be announced at various times throughout the day. Text the keyword to the WCTO REQUEST LINE 610-720-9696 during the Contest Period. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Only one (1) entry per person per phone number per giveaway will count as a submission for the duration of the contest period. Multiple daily texts will be accepted but will not increase your odds of winning. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes.
- 4. **Winner Selection.** There will be two (2) winners for each giveaway during the contest period. One (1) giveaway each day. Stations text platform Marketron will determine a random winner each giveaway to win the prize. The winning entrants will be contacted using the phone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of

these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
